### PRODUCTS DESCRIPTION

Climate Control pressure vessels range features pressure expansion vessels with fixed gas charge for heating, solar, cooling water, and potable water systems (Aquapresso range). IMI offers a range of high-quality pressure vessels for HVAC and hydronic systems. This document is representative for all IMI vessels range produced in Polish factory – Statico SD, Aquapresso AD, ADF, as well as all variants of intermediate and secondary DD vessels of specified size. Pressure vessels ensure optimal pressure stability, system efficiency, and longevity across HVAC and potable water applications, setting the industry standard for reliability and performance. Vessels are predominantly made of steel variant components and butyl bag; some additional plastic and brass components are included for the assessment. Vessels are painted with beryllium paint. Suitable for non-aggressive and non-toxic system media with addition of antifreeze agent up to 50%.

Main functions:

- Pressure stabilization in the water systems
- Volume compensation for thermal expansion
- For specific usage temperatures or pressure class check specific product technical sheet.

### LIFE CYCLE ASSESSMENT (LCA) – general rules applied

#### Unit

The declared unit is 1 kg of Pressure Vessels 8-80L products. Declared unit refer to different numbers and types of vessels; every vessels typology contains vessels with different dimensions and weights. However, the same manufacturing process and the similarities of vessels allow a declared unit based on mass unit of products.

#### System boundary

The life cycle analysis of the declared products covers “Product Stage” A1-A3, A4-A5, C1-C4+D modules in accordance with EN 15804 and ITB PCR A (cradle to gate with options). Energy and water consumption, emissions as well as information on generated wastes were inventoried and were included in the calculation. It can be assumed that the total sum of omitted processes does not exceed 5% of all impact categories. In accordance with EN 15804+A2, machines and facilities (capital goods) required for the production as well as transportation of employees were not included in LCA.

#### Allocation

The allocation rules used for this EPD are based on general ITB 's document PCR A. In the modules A1-A3, material losses in the assembly of the products in the factory are defined on the averaged specific values for the site. Input and output data from the production is inventoried and allocated to the production on the mass basis. The declaration covers a wide range of products (averaged). Their production resources and processing stages are basically similar, so it is possible to average the production by product volume.

#### System limits

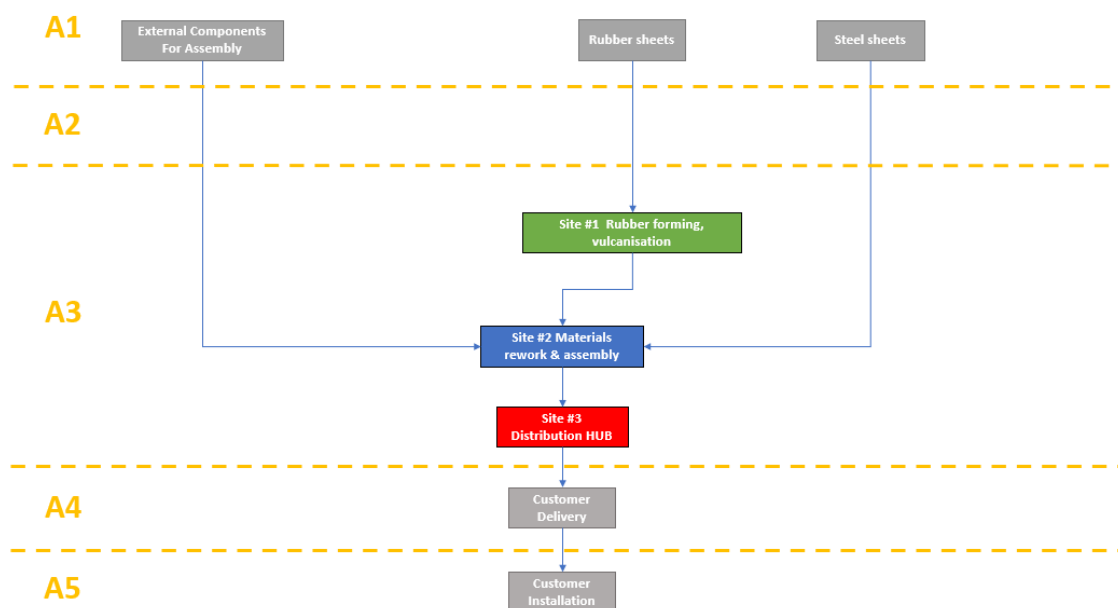
99.0% materials and 100% energy consumption were inventoried in a factory and were included in calculation. In the assessment, all significant parameters from gathered production data are considered, utilized energy, and electric power consumption, direct production waste, and available emission measurements. The total of neglected input flows per module A1-A3 does not exceed the permitted maximum of 1 % of energy usage and product mass. Tires consumption for transport was not taken into account. The components like: foils, papers, labels, tapes with a percentage share of less than 0.1% were not included in the calculations. It is assumed that the total sum of omitted processes does not exceed 1% of all impact categories. In accordance with EN 15804 machines and facilities (capital goods) required for and during production are excluded, as is transportation of employees.

#### **Modules A1 and A2: *Raw materials supply and transport***

The modules A1 and A2 represent the extraction and processing of raw materials (mainly steel components and butyl bag; some additional plastic and brass components are included for the assessment) and transport to the production site. For A2 module (transport- inventoried) European averages for fuel data are applied. Production of metal and plastic elements (inputs to production in Olkusz) were inventoried and assessed.

#### **Module A3: *Production***

The product specific manufacturing process is presented in Figure 2. The production process is partially automated and is based on receiving metallurgical materials for production. Components previously made go to the factory in Olkusz where they are assembled into one final product. The pieces are mechanically worked and assembled with vessels components. Some pieces and valve components are coated with chrome and powder, according to the valve typologies in which they are used.

#### **Module A4: transport to consumer**

Vehicle transport at distance 500 km is considered (emission standard: Euro 5) with 100% load capacity.

#### **Modules C and D: End-of-life (EOL)**

Due to the fact that the declaration covers a wide range of products for various purposes and usage scenarios, it is not possible to directly specify the de-construction technology and the amount of energy for disassembly in C1 module (so this module is generic based on literature/electricity consumption). In the adapted end-of-life scenario, the de-constructed steel products are transported to a metal mill distant by 100 km on > 16t lorry EURO 5 where are used as scrap to produce a new metals. The recycling potential of C3 module is 98% and it is assumed that only 2% of the products will end up in a landfill – C4 module (Table 1). Module D presents credits resulting from the recycling of the scrap (used for steel production), calculated in accordance with the approach developed by World Steel Association.

Electricity at end-of-life (module C) has been modelled using an average Polish electricity mix as the location where the product reaches end-of-life is unknown.

#### **Data collection period**

The data for manufacture of the declared products refer to period between 01.01.2023 – 31.12.2023 (1 year). The life cycle assessments were prepared for Poland and Europe as reference area.

#### **Data quality**

The data selected for LCA originate from ITB-LCI questionnaires completed by IMI International Sp. z o. o. and verified during data audit. No data collected is older than five years and no generic datasets used are older than ten years. The representativeness, completeness, reliability, and

consistency is judged as good. The background data for the processes come from the following resources database Ecoinvent v.3.10.

### Assumptions and estimates

The impacts of the representative products were aggregated using weighted average.

### Calculation rules

LCA was performed using ITB-LCA tool developed in accordance with EN15804+A2 and EF 3.1 factors. No mass balance approach was used. Biogenic carbon balance was provided.

### Additional information

The manufacturer provided certificates of origin of electricity from renewable energy sources based on the renewable energy. Electricity (Ecoinvent v.3.10 data) emission factor (used is 0.1 kg CO<sub>2</sub>/kWh. As a general rule, no particular environmental or health protection measures other than those specified by law are necessary. The product may contain dangerous substances (lead), more than 0,1% by weight, given by the REACH Candidate List.

## LIFE CYCLE ASSESSMENT (LCA) – Results

### Declared unit

The declaration refers to declared unit (DU) – 1 kg of Pressure Vessels 8-80L produced in Europe. The following life cycle modules (Table 2) were included in the analysis. The following tables 3-6 show the environmental impacts of the life cycle of selected modules (A1-A5+C1-C4+D).
